SUBJECT: IDENTIFIED CENTERS OF EXCELLENCE AND CENTERS OF DEVELOPMENT IN CRIMINOLOGY PROGRAM

In accordance with the pertinent provisions of Republic Act No. 7722, otherwise known as the "Higher Education Act of 1994", CHED Memorandum Order (CMO) No. 48, s. 2006 entitled "*Criteria and Implementing Guidelines for the Identification, Support and Development of Centers of Excellence (COEs) and Centers of Development (CODs) for Criminology Program*", with the recommendation of the Office of Programs and Standards (OPS) and the Technical Panel for Criminal Justice Education (TPCJE) and by virtue of the 317th Commission *en banc* Resolution No. 365 - 2008 dated 14 July 2008, the *Criminology program* of the following higher education institutions (HEIs) are hereby identified and designated as COEs and CODs in Criminology by the Commission, thus:

The designation of the foregoing HEIs as COE and COD in Criminology, respectively, shall not be misconstrued that the same applies to other programs offered by the said institutions. Said HEIs shall be subject to periodic monitoring/evaluation by CHED through the OPS and if found not maintaining compliance with the criteria as COE/COD, the designation shall be revoked.

EFFECTIVITY

This designation shall take effect from the date it has been formally awarded by the Commission, over a period of **three (3) years**.

REAPPLICATION

Pursuant to CMO No. 6, s. 2007, HEIs that applied during the call for application as COE or COD in the Criminology program and were not able to meet the requirements specified in the selection criteria may only reapply two (2) years after the date of the CEB Resolution approving this COE/COD designation as mentioned above.
