Invitation to Bid

- The Commission on Higher Education (CHED) through the Bids and Awards Committee (BAC) invites Contractors to apply for eligibility and, if found eligible, to bid for the following Contract:

Contract Name : CONSTRUCTION OF PROPOSED 3RD FLOOR WITH ROOFING OF CHEDRO VI BUILDING

Location : Magsaysay Road, West Visayas State University (WVSU) Campus, La Paz, Iloilo City

Approved Budget for the Contract (ABC) : Php 4,340,000.00 (*bids in excess of the ABC shall be automatically rejected at bid opening*)

Contract Duration : 120 Calendar Days

The BAC will conduct this public bidding in accordance with R.A. 9184 and its Implementing Rules and Regulations.

- Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

- The times and deadlines set for the major procurement activities are shown below:

3. Receipt of Bids: First Envelope (Eligibility/Technical Component), and Second Envelope (Financial Component)	Deadline: Time: 9:00 am Date: July 24, 2017
4. Opening of Bids	Time: 10:00 am Date: July 24, 2017

5. Interested bidders may obtain further information from the CHED BAC Secretariat and inspect the Bidding Documents at the address given below from *June 30-July 24, 2017, Monday(s) thru Friday(s) at 8:00 AM to 5:00 PM.*
6. A complete set of Bidding Documents may be acquired by interested bidders from the address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php 5,000.00.* Bidder/s who will purchase the Bidding Documents from the CHED Regional Office VI shall deposit the non-refundable fee to the account of the *Commission on Higher Education with Account number 0072-1057-06 at Landbank Q.C. Circle branch and email the copy of the deposit slip address to CHEDCO BAC Secretariat at email address bacsecretariat@ched.gov.ph*

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
7. The submission of Bids (Eligibility/Technical Component and Financial Component) should be hand carried to the BAC Secretariat through the Security Guard's information desk located at the lobby of the HEDC Building, C.P. Garcia Avenue, UP-Diliman, Quezon City on or before July 24, 2017, 9:00 am. The guard on duty will log the arrival time of the bidders on their bid envelopes. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18 or accompanied by a Bid Securing Declaration. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
8. The Award of Contract shall be made to the Lowest Calculated and Responsive Bid (LCRB) which complies with the minimum Technical and Financial Component of the Bids.
9. The Commission on Higher Education reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
