"Declaration of failure of bidding for the Procurement of Security Service for CHED for FY 2021 (9 months) and conduct of rebidding"

WHEREAS, the Commission on Higher Education advertised the Invitation to Bid (ITB) for the conduct of public bidding for the **Procurement of Security Service for CHED for FY 2021 (9 months)** with an Approved Budget for the Contract (ABC) amounting to **Six Million Five Hundred Thousand Six Hundred Seventeen Pesos & 65/100 (P6,500,617.65)** and posted on February 22, 2021 at the websites of PhilGEPS (www.philgeps.gov.ph) with Reference No. 7487639 and CHED (www.ched.gov.ph) and at the premises of the Department of Information and Communications Technology (DICT), Philippine Institute of Volcanology and Seismology (PhiVolcs), and HEDC Building at UP-Diliman in Quezon City;

WHEREAS, in response to said advertisement, fourteen (14) prospective bidders browsed the opportunity as per Document Request List at the website of the PhilGEPS (www.philgeps.gov.ph) namely: (a) STAR SPECIAL CORPORATE SECURITY MANAGEMENT, INC., (b) CIRCA SECURITY AND INVESTIGATION, INC., (c) NORTHERN STAR INVESTIGATION AND SECURITY AGENCY, INC., (d) AGILEX SECURITY AGENCY, INC., (e) ONE MERIT GLOBAL JANITORIAL SERVICES, INC. (f) BLUE ARMEE SECURITY & INVESTIGATION CORPORATION, (g) FEMJEG SECURITY AGENCY, (h) HACKETT SECURITY AGENCY, (i) LOCKHEED FEDERAL SECURITY AGENCY, INC., (j) REDBIRD SECURITY AGENCY & SERVICES, INC., (k) CATENA SECURITY, INC., (l) BLUE CAVALIER SECURITY AGENCY, INC., (m) ARVITER TOP OF THE LINE SEC. INVEST. SPECIALIST, and (n) DARK HORSE SECURITY AGENCY, INC.;

WHEREAS, out of the fourteen (14) prospective bidders who were in the document Request List at the website of PhilGEPS (www.philgeps.gov.ph) and those who read the Invitation to Bid that was posted at the CHED website (www.ched.gov.ph) and at the three conspicuous places, two (2) bidders namely: (a) STAR SPECIAL CORPORATE SECURITY MANAGEMENT, INC., and (b) NAPROSSI SECURITY SERVICES, INC. availed of the bidding documents;

WHEREAS, the Bids and Awards Committee (BAC) issued Notice of Change of Time on February 24, 2021 for the rescheduling of Pre-Bid Conference from March 3, 2021 at 10:00 A.M to March 3, 2021 at 1:00 P.M;

WHEREAS, during the Pre-Bid Conference on March 3, 2021, attended by the eight (8) prospective bidders namely: (a) OPERATIONS MANAGER BLUE CAVALIER SECURITY AGENCY, (b) LOCKHEED GLOBAL SECURITY AND INVESTIGATION SERVICES, INC., (c) ARVITER TOP OF THE LINE SECURITY INVESTIGATION SPECIALIST, (d) STAR SPECIAL CORPORATE SECURITY MANAGEMENT, INC., (e) HACKETT SECURITY AGENCY, (f) AREMOS SECURITY AND INVESTIGATION AGENCY, (g) DARK HORSE SECURITY AGENCY, INC., and (h) NAPROSSI SECURITY SERVICES, INC., clarifications were raised. However, the BAC did not issue a bid bulletin;

WHEREAS, during the Submission and Opening of Bids on March 15, 2021, two (2) bidders namely: (a) STAR SPECIAL CORPORATE SECURITY MANAGEMENT, INC., and (b) NAPROSSI SECURITY SERVICES, INC. submitted their Eligibility/Technical Bid Envelopes and Financial Bid Envelopes to the Bids and Awards Committee (BAC);

WHEREAS, after opening the first envelope in public which contained the Eligibility documents and technical bid, the BAC requested the assistance of the Technical Working Group for Other Goods and Services (TWG-OGS) for the evaluation of the documents;

WHEREAS, the BAC, upon thorough evaluation, found the following:

WHEREAS, the BAC resolved to declare **STAR SPECIAL CORPORATE SECURITY MANAGEMENT, INC.** as **"ineligible"** for submitting: (1) SSS Clearance as of September 23, 2019 instead of the required SSS Clearance that the company have no arrears and there is no pending case against them as of October 31, 2020, (2) Pag-ibig Certificate Remittance as of October 19, 2020 instead of Pag-ibig Fund Certificate that premium payments have been remitted as of December 31, 2020, and (3) PhilHealth Certification Remittance as of September 2020 instead of PhilHealth Certification that premium payments have been remitted as of December 31, 2020 and further, declared that it **"failed"** the technical requirements of the bid;

WHEREAS, the BAC resolved to declare **NAPROSSI SECURITY SERVICES, INC.** as **"ineligible"** for failure to submit the required documents as follows: (1) SSS Clearance that the company have no arrears and there is no pending case against them as of October 31, 2020, instead submitted an Official Receipt (OR) as proof of remittance, (2) Pag-ibig Fund Certificate that premium payments have been remitted as of December 31, 2020, instead submitted an Official Receipt (OR) as premium payments for the months of October, November, and December 2020, and (3) PhilHealth Certification that premium payments have been remitted as of December 31, 2020, instead submitted an Official Receipt as premium payments for the months of January to February 2021, and further the BAC declared that it **"failed"** the technical requirements of the bid;

WHEREAS, the BAC, considering that all bidders are ineligible, resolved to declare a **"failure of bidding"** for the Procurement of Security Service for CHED for FY 2021 (9 months) and conduct of rebidding;

WHEREFORE, RESOLVE AS IT IS HEREBY RESOLVED, that the Bids and Awards Committee hereby declare a **"failure of bidding"** for the **Procurement of Security Services for CHED for FY 2021 (9 months) and conduct of rebidding.**

WHEREAS, the BAC resolved to declare **NAPROSSI SECURITY SERVICES, INC.** as **"ineligible"** for failure to submit the required documents as follows: (1) SSS Clearance that the company have no arrears and there is no pending case against them as of October 31, 2020, instead submitted an Official Receipt (OR) as proof of remittance, (2) Pag-ibig Fund Certificate that premium payments have been remitted as of December 31, 2020, instead submitted an Official Receipt (OR) as premium payments for the months of October, November, and December 2020, and (3) PhilHealth Certification that premium payments have been remitted as of December 31, 2020, instead submitted an Official Receipt as premium payments for the months of January to February 2021, and further the BAC declared that it **"failed"** the technical requirements of the bid;

WHEREAS, the BAC, considering that all bidders are ineligible, resolved to declare a **"failure of bidding"** for the Procurement of Security Service for CHED for FY 2021 (9 months) and conduct of rebidding;

WHEREFORE, RESOLVE AS IT IS HEREBY RESOLVED, that the Bids and Awards Committee hereby declare a **"failure of bidding"** for the **Procurement of Security Services for CHED for FY 2021 (9 months) and conduct of rebidding.**
