BAC RESOLUTION NO. 2021-025

*"Declaration of 'failure of bidding' for the Procurement of Security Service for CHED for
FY 2021 (6 months) and conduct of rebidding"*

WHEREAS, the Commission on Higher Education advertised the Invitation to Bid (ITB) for the conduct of public bidding for the **Procurement of Security Service for CHED for FY 2021 (6 months)** with an Approved Budget for the Contract (ABC) amounting to **Four Million Three Hundred Forty Five Thousand Four Hundred Thirty Five Pesos & 14/100 (P4,345,435.14)** and posted on April 10, 2021 at the websites of PhilGEPS (www.philgeps.gov.ph) with Reference No. 7607504 and CHED (www.ched.gov.ph) and at the premises of the Department of Information and Communications Technology (DICT), Philippine Institute of Volcanology and Seismology (PhiVolcs), and HEDC Building at UP-Diliman in Quezon City;

WHEREAS, in response to said advertisement, twelve (12) prospective bidders browsed the opportunity as per Document Request List at the website of the PhilGEPS (www.philgeps.gov.ph) namely: (a) SNIFFER K9 AND SECURITY SOLUTIONS, INC., (b) HACKETT SECURITY AGENCY, (c) NORTHERN STAR INVESTIGATION AND SECURITY AGENCY, INC., (d) CADMAN INVESTIGATION AND SECURITY AGENCY, (e) BAGUIO INVESTIGATION AND SECURITY AGENCY, INC., (f) REDBIRD SECURITY AGENCY & SERVICES, INC., (g) BLUE ARMEE SECURITY & INVESTIGATION CORPORATION, (h) STAR SPECIAL CORPORATE SECURITY MANAGEMENT, INC., (i) GRAND MERITUS SECURITY AGENCY, INC., (j) ST. MORITZ SECURITY AGENCY, INC., (i) ARVITER TOP OF THE LINE SEC. INVEST. SPECIALIST, and (k) TOPBEST SECURITY AGENCY, INC.;

WHEREAS, out of the twelve (12) prospective bidders who were in the document Request List at the website of PhilGEPS (www.philgeps.gov.ph) and those who read the Invitation to Bid that was posted at the CHED website (www.ched.gov.ph) and at the three conspicuous places, two (2) bidders namely: (a) STAR SPECIAL CORPORATE SECURITY MANAGEMENT, INC., and (b) NAPROSSI SECURITY SERVICES, INC. availed of the bidding documents;

WHEREAS, during the Pre-Bid Conference on April 21, 2021, attended by the five (5) prospective bidders namely: (a) STAR SPECIAL CORPORATE SECURITY MANAGEMENT, INC., (b) LOCKHEED GLOBAL SECURITY AND INVESTIGATION SERVICES, INC., (c) NAPROSSI SECURITY SERVICES, INC., (d) FARAGON SECURITY AGENCY, and (e) BEST CARE INTERNATIONAL SECURITY, clarifications were raised. However, the BAC did not issue a bid bulletin;

WHEREAS, during the Submission and Opening of Bids on May 3, 2021, two (2) bidders namely: (a) STAR SPECIAL CORPORATE SECURITY MANAGEMENT, INC., and (b) NAPROSSI SECURITY SERVICES, INC. submitted their Eligibility/Technical Bid Envelopes and Financial Bid Envelopes to the Bids and Awards Committee (BAC);

WHEREAS, after opening the first envelope in public which contained the Eligibility documents and technical bid, the BAC requested the assistance of the Technical Working Group for Other Goods and Services (TWG-OGS) for the evaluation of the documents;

WHEREAS, the BAC, upon thorough evaluation, found the following:

WHEREAS, the BAC resolved to declare **STAR SPECIAL CORPORATE SECURITY MANAGEMENT, INC.** as **"ineligible"** and further, declared that it **"failed"** the technical requirements of the bid for the following reasons:

Certification from Pag-ibig Fund that premium payments have been remitted as of December 31, 2020	The Star Special Corporate Security Management, Inc. submitted a Pag-ibig Certificate Remittance as of October 2020 dated October 19, 2020
Certification from Philhealth that premium payments have been remitted as of December 31, 2020	The Star Special Corporate Security Management, Inc. submitted a PhilHealth Certification Remittance as of September 2020 dated October 20, 2020

WHEREAS, the BAC resolved to declare **NAPROSSI SECURITY SERVICES, INC.** as **"ineligible"** and further, declared that it **"failed"** the technical requirements of the bid for the following reasons:
