**WHEREAS**, the Bids and Awards Committee (BAC) deliberated on the approved Purchase Request (PR) from the Office of Chairperson and Commissioners (OCC) per approved Project Procurement Management Plan (PPMP) / Annual Procurement Plan (APP) for FY 2021;

**WHEREAS**, the approved Annual Procurement Plan (APP) included the Project Procurement Management Plan (PPMP) of the Office of Chairperson and Commissioners (OCC) for the **procurement of Wearable Air Purifier** with an Approved Budget for the Contract (ABC) amounting to **Nine Hundred Ninety Seven Thousand Five Hundred Pesos (P997,500.00)** and **"Small Value Procurement under Negotiated Procurement"** was approved as the appropriate alternative method of procurement to be adopted under Section 53.9 of the revised IRR of the RA 9184;
