BAC RESOLUTION NO. 2022-026

"Recommendation to award the contract to M.P EVANGELISTA CATERING SERVICES for the Procurement of catering services for the CEB & Joint ManCom/CEB Meetings for March to December 2022"

WHEREAS, the Commission on Higher Education advertised the Invitation to Bid (ITB) for the conduct of public bidding for the **Procurement of catering services for the CEB & Joint ManCom/CEB Meetings for March to December 2022** with an Approved Budget for the Contract (ABC) amounting to **One Million Four Hundred Forty Nine Thousand (P1,449,000.00)** and posted on February 3, 2022 at the websites of PhilGEPS (www.philgeps.gov.ph) with Reference No. 8393894 and CHED (www.ched.gov.ph) and at the premises of the Department of Information and Communications Technology (DICT), Philippine Institute of Volcanology and Seismology (PhiVolcs), and HEDC Building at UP-Diliman in Quezon City;

WHEREAS, in response to said advertisement, six (6) prospective bidders browsed the opportunity as per Document Request List at the website of the PhilGEPS (www.philgeps.net) namely: (a) DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS CENTRAL OFFICE MULTI PURPOSE COOPERATIVE, (b) FORTUNE GATE CORPORATION, (c) WEST HEAVEN TRADING CORPORATION, (d) M.P. EVANGELISTA CATERING SERVICES, (e) PIAFLOR CATERING SERVICE, and (f) DREAMERSCORNER PH EVENTS MANAGEMENT SERVICES;

WHEREAS, out of the six (6) prospective bidders who were in the Document Request List at the website of the PhilGEPS (www.philgeps.gov.ph) and those who read the Invitation to Bid that was posted at the CHED website (www.ched.gov.ph) and at the three conspicuous places, one (1) prospective bidder namely: M.P. EVANGELISTA CATERING SERVICES, availed of the bidding documents;

WHEREAS, during the Pre-Bid Conference on February 11, 2022, attended by three (3) prospective bidders, namely: (a) RLCL FOOD HALL, (b) M.P. EVANGELISTA CATERING SERVICES, and (c) BEST CHOICE AND CATERING SERVICE there were clarifications raised and the BAC immediately addressed these issues and concerns during the Pre-Bid Conference;

WHEREAS, during the Submission and Opening of Bids on February 28, 2022, one (1) bidder, namely: M.P. EVANGELISTA CATERING SERVICES submitted their Eligibility/Technical Bid Envelopes and Financial Bid Envelopes to the Bids and Awards Committee (BAC);

WHEREAS, the BAC, after opening the first envelope in public which contained the Eligibility requirements and Technical documents, requested the assistance of the Technical Working Group for Other Goods and Services (TWG-OGS) for the evaluation of the documents;

WHEREAS, the BAC, upon thorough evaluation, found the following:

WHEREAS, the BAC resolved to declare **M.P. EVANGELISTA CATERING SERVICES** as **"eligible"** for complying with the eligibility requirements and technical bid documents and further declared that they **"passed"** the requirements of the bids;

WHEREAS, the BAC, after opening the second envelope which contained the financial bid, requested the assistance of the Technical Working Group for Other Goods and Services (TWG-OGS) for the evaluation and to examine the completeness of the requirements of the financial components of the bid;

WHEREAS, the BAC, upon thorough evaluation, found the following:

WHEREAS, the BAC, upon deliberation, declared that **M.P. EVANGELISTA CATERING SERVICES "passed"** the requirements of the financial components of the bid;

WHEREAS, the BAC declared the bid price "as read" as follows:

WHEREAS, the BAC requested the assistance of the Technical Working Group for Other Goods and Services (TWG-OGS) to evaluate the submitted financial bid;


WHEREAS, the BAC, upon thorough evaluation, declared the bid price "as calculated" as follows:

BIDDER	BID AS CALCULATED
M.P. EVANGELISTA CATERING SERVICES	P1,291,500.00

WHEREAS, the BAC, upon deliberation, declared that **M.P. EVANGELISTA CATERING SERVICES "passed"** the eligibility, technical and financial components of the bid in the amount of **One Million Two Hundred Ninety One Thousand Five Hundred Pesos (P1,291,500.00)** and further declared as the **Single Calculated Bid (SCB)** subject to the conduct of post-qualification evaluation;

WHEREAS, on March 2, 2022 regular BAC meeting, the BAC with the assistance of the TWG-OGS together with the BAC Secretariat and the end-user, upon **post qualification evaluation** through **virtual ocular inspection** and **validation of documents** conducted on March 1, 2022, and compliance on the technical requirements determined by the end-user on March 2, 2022, found **M.P. EVANGELISTA CATERING SERVICES** responsive with the eligibility and technical specification requirements of the bid;

WHEREAS, the BAC upon motion duly seconded resolved to recommend the award of the contract to **M.P. EVANGELISTA CATERING SERVICES** as the **Single Calculated and Responsive Bid (SCRB)** for the **Procurement of catering services for the CEB & Joint ManCom/CEB Meetings for March to December 2022;**

WHEREFORE, RESOLVE AS IT IS HEREBY RESOLVED, that the Bids and Awards Committee hereby recommends for approval by the Commission en Banc (CEB) the award of the contract to **M.P. EVANGELISTA CATERING SERVICES** in the total amount of **One Million Two Hundred Ninety One Thousand Five Hundred Pesos (P1,291,500.00)** for the **Procurement of catering services for the CEB & Joint ManCom/CEB Meetings for March to December 2022.**
