SUBJECT : AMENDMENT TO SECTION V D-1(f) OF CMO NO. 10, SERIES OF 2020 ENTITLED "IMPLEMENTING GUIDELINES FOR BAYANIHAN 2 FOR HIGHER EDUCATION TULONG PROGRAM (B2HELP) AS PROVIDED IN SECTION 4(n) OF REPUBLIC ACT NO. 11494, OTHERWISE KNOWN AS THE BAYANIHAN TO RECOVER AS ONE ACT"

In accordance with the pertinent provisions of Republic Act (RA) No. 7722, otherwise known as the "Higher Education Act of 1994", RA 11494 "Bayanihan to Recover As One Act", and by virtue of Commission en banc (CEB) Resolution No. 095-2021 dated 9 March 2021, the hereunder amendment to CMO 10, series of 2020 is hereby adopted and promulgated for the guidance of all concerned stakeholders and to ensure that the appropriations are properly administered and implemented according to its purpose.

Section V. D Liquidation Procedures of CMO 10, series of 2020 is hereby amended to read as follows:

1. Partner institutions shall submit the following liquidation documents:

- f. For private Partner Institution, (1) an original copy of certification signed by the Head of the Institution providing the list of grantees who have benefitted the grant and indicating that the amount granted were credited to the outstanding tuition and miscellaneous balance of each student-grantee, and (2) certified true copy of individual statement of account (SOA) reflecting the credit of the grant from the outstanding tuition and miscellaneous balance of each student-grantee." Prescribed templates as Annexes E and F are hereto attached, for ready reference and compliance.

All other provisions of CMO No. 10, series of 2020 not affected by this amendment shall remain valid and enforceable.
