
This is to inform you that your total offer of **Fifty Thousand Pesos (P50,000.00)** for the **Procurement of service provider for the Refill of Fire Extinguisher** is hereby accepted. This acceptance, however, is subject to the following:

1. That all work shall be in the best workmanship possible;
2. That the work shall be done according to the requirements/specifications stated in the scope of works as follows:
 - a. 70 pcs Dry Chemical (Red) 10 lbs;
 - b. 2 pcs Dry Chemical (Red) 50 lbs;
 - c. 13 pcs HCFC 123 (Green) 10 lbs;
 - d. Including:
 1. Leak Test;
 2. Reconditioning;
 3. Cleaning and Repainting of Unit;
 4. Repair/Replacement of defective hose;
 5. Replacement of unit during refilling;
 6. Pick-up and delivery of units;
3. That the work shall be finished in not more than fourteen (14) calendar days;
4. That the prices should be inclusive of VAT and other government charges.
5. That in case the calendar days per quarter are exceeded, a penalty of one tent (1/10) of one percent (1%) of the total amount of the contract shall be imposed for everyday of delay;
6. In case of failure to finish the work as stipulated in the Job Order, a liquidated damage of one tenth of one percent (.001) of the total amount shall be charged on the unfinished portion of work, reckoned from the contractor's receipt of the Job Order up to that day/date of the contractor's receipt of the Owner's Notice of Termination. The Owner reserves the right to enter into another contract to finish the work charging to delinquent contractor the difference in cost, if any;
7. That this contract is subject to warranty against mechanical defects and workmanship for sixty (60) calendar days from the date of final acceptance.
8. That this transaction is subject to government accounting and auditing rules and regulations.



