Deadline for accepting comments is on March 24, 2021 (Wednesday).


2. **[URGENT]** To coordinate with HEIs issued with Authority to Conduct Limited Face-to-Face Classes on the data of vaccinated students/clerks and other related information on the vaccination.

4. To organize virtual group conversations and channels for HEI Officials conducting and/or intending to conduct limited face-to-face classes in order to provide a space where HEI Officials can easily share best practices and exchange ideas on the conduct of limited face-to-face classes; and
