1. CALL TO ORDER

There being a quorum, the meeting was called to order at 9:20 PM with the BAC Chairperson, Atty. Cinderella Filipina S. Benitez-Jaro, presiding.

2. INTRODUCTION OF BIDDERS/REPRESENTATIVES/ BAC/TWG-OGS/ OBSERVER

Upon the instruction of the BAC Chairperson, Mr. Nelson E. Espina, Head of the Secretariat, presented the bidder who attended the bid opening. He introduced the BAC members, TWG-OGS members, BAC Secretariat, COA representative, Consultant and end-user who were present during the bid opening.

In addition, Mr. Espina informed also the Committee that invitations were sent to the COA representative and to three (3) GPPB- recognized Observers namely, Mr. Vicente T. Lazatin, Executive Director-Transparency Accountability Network (TAN), Mr. Crisanto S. Frianeza, Secretary-General, Philippine Chamber of Commerce and Industry (PCCI) and Ms. Imelda Carillo, Philippine Institute for Supply Management (PISM). Said invitations were confirmed received by the invited observers. However, only the COA representative attended the bid opening.

Mr. Artemio S. Capellan, Jr, member of the Secretariat, mentioned the sixteen (16) service providers who viewed the posting at PhilGEPS per Document Request List, namely: a) Advance Solutions, Inc., b) Integrated Computer Systems, Inc., c). American Technologies Inc., d) Accel Prime Technologies Inc., e) MCSA Marketing, f). Konek-IT Network Technologies, Inc., g) I-Asiatic Innovations Phils. Inc., h). Masangkay Computer Center, i). Gocom Systems and Solutions Corp., j). IEquity Technologies Corp., k). Epartners Solutions, Inc. l). EPLDT, Inc. m). Trends and Technologies, Inc., n). Yondu Inc., o). IPSolutions Inc., p). Microimaging Sales and Services, Inc. However, only Microgenesis Software, Inc, doing business under the name and style of Microgenesis Business System, availed of the bidding documents and submitted the technical and financial bid documents including the Financial bid envelope.

3. OPENING OF THE FIRST ENVELOPE (ELIGIBILITY DOCUMENTS/, EXAMINATION OF ELIGIBILITY DOCUMENTS AND THE TECHNICAL PROPOSAL, EXAMINATION AND DETERMINATION OF RESPONSIVENESS AND DECLARATION OF ELIGIBLE/INELIGIBLE BIDDERS

Upon the instruction of the BAC Chairperson, the Secretariat presented to the BAC the sealed envelope submitted by Microgenesis Software, Inc, doing business under the name and style of Microgenesis Business System. The BAC Chairperson opened the **sealed envelope** in public and requested the assistance of the members of the Technical Working Group for Other Goods and Services (TWG-OGS) to evaluate the technical components of the bid including the eligibility requirements.

The bidder's envelopes were opened and the name/label was read. The documents inside the envelope which was marked "**original copy**" of the technical components of the bid including the eligibility requirements was forwarded to the members of the BAC for affixing of their initials in each page. The documents inside the envelope which was marked "**copy 1**" was used as reference by the members of the TWG-OGS for eligibility checking and evaluation purposes. The sealed envelope which was marked "**copy 2**" was entrusted to the Secretariat for safekeeping and custody.

Upon careful checking of the eligibility documents, the members of the TWG-OGS reported to the Bids and Awards Committee the result of their evaluation, as follows;

4. OPENING OF THE SECOND ENVELOPE (FINANCIAL PROPOSAL), EXAMINATION OF FINANCIAL PROPOSAL AND DETERMINATION OF RESPONSIVENESS AND READING OF FINANCIAL PROPOSAL AND THE APPROVED BUDGET FOR THE CONTRACT (ABC)

The BAC Chairperson opened the second envelope which was marked "original copy" which contained the financial bid component of Microgenesis Software, Inc. doing business under the name and style of Microgenesis Business System and forwarded to the members of the BAC for affixing of their initials in each page. The documents inside the envelope which was marked "copy 1" was used as reference by the members of the TWG-OGS for checking and evaluation purposes. The sealed envelope which was marked "copy 2" was entrusted to the Secretariat for safekeeping and custody.

5. TECHNICAL WORKING GROUP FOR OTHER GOODS AND SERVICES RECOMMENDATION

The bid proposal of Microgenesis Software, Inc. doing business under the name and style of Microgenesis Business System after having "passed" the technical evaluation, and their financial bid is within the Approved Budget for the Contract (ABC), was recommended as the "Single Calculated Bid", subject to post-qualification evaluation.

The BAC informed the representative of Microgenesis Software, Inc. doing business under the name and style of Microgenesis Business System that their bid was declared as the Single Calculated Bid and shall undergo post-qualification evaluation and will be notified on the schedule of post-qualification.
