The Commission on Higher Education (CHED), through the Office of Institutional Quality Assurance and Governance (OIQAG), shall conduct a virtual public consultation on the proposed DBM-CHED Joint Circular (JC) for the Reclassification of Faculty Positions in State Universities and Colleges (SUCs).

In this connection, all CHED Directors, SUC Presidents, Officers of Faculty Associations in SUCs, and all faculty members in SUCs, are invited to attend the said virtual public consultations that will be conducted on the following schedule:

Due to the limited capacity of the platform, only eight (8) representatives per SUC shall be allowed to pre-register and join the virtual room. The other interested participants are encouraged to tune in the CHED Facebook page for the live stream. To ensure representation of sectors, the representatives in the virtual room shall be a combination of the SUC Officials, Faculty Association Officers, and faculty members who are not Officers of the Faculty Association.
