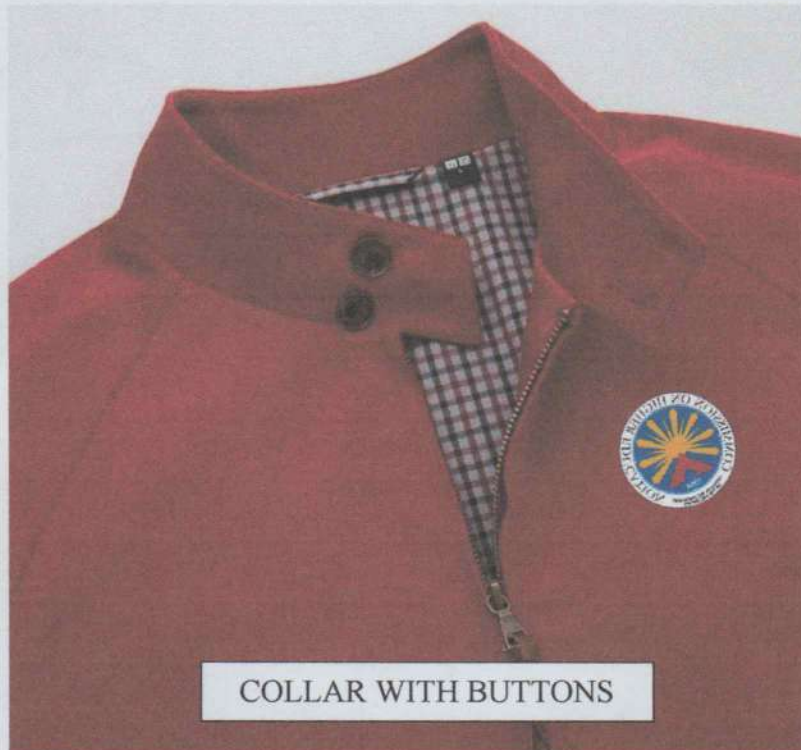

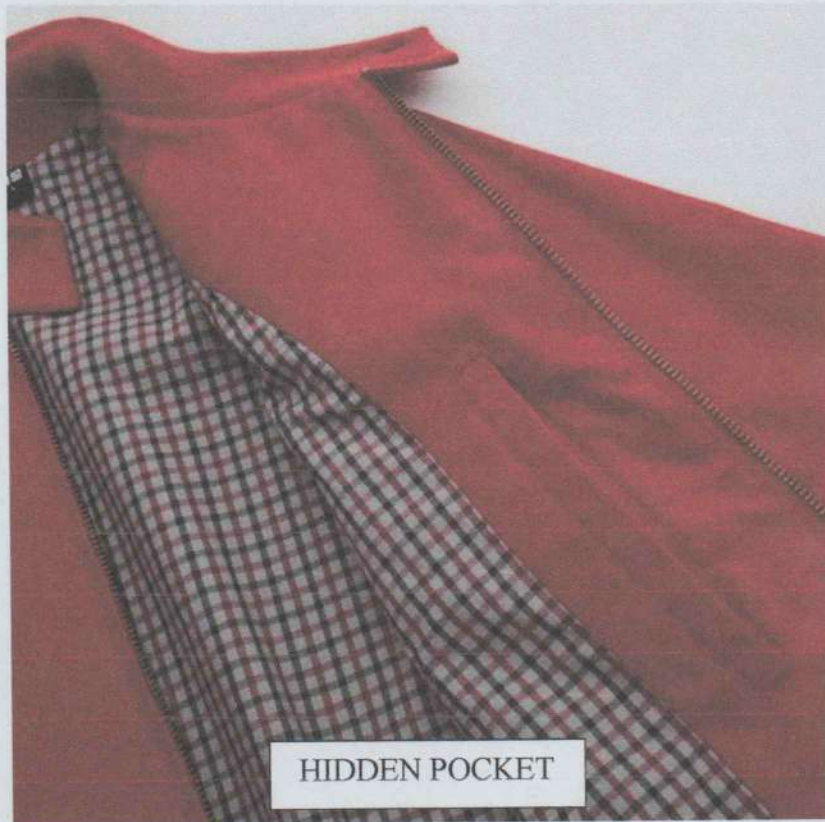

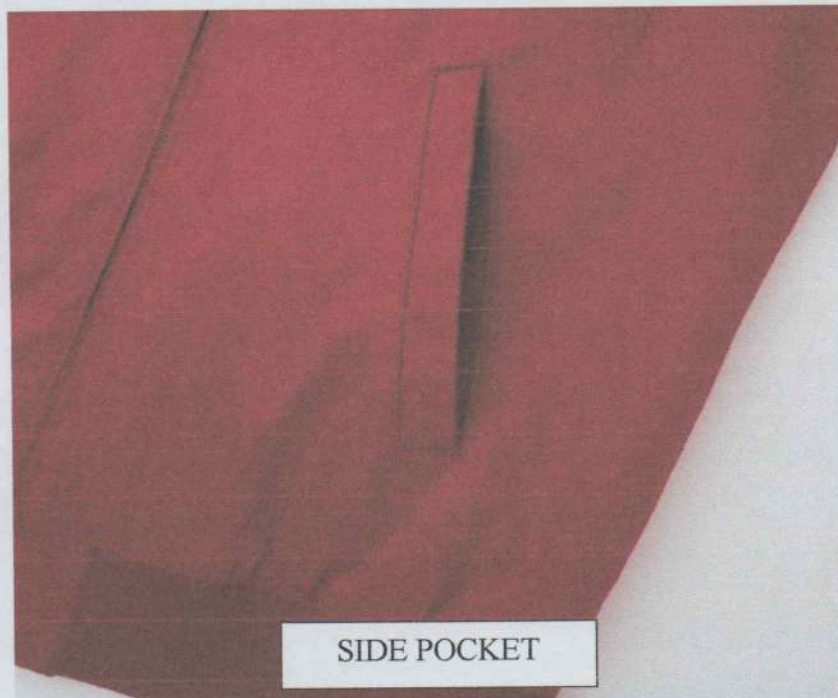

SIDE POCKET




