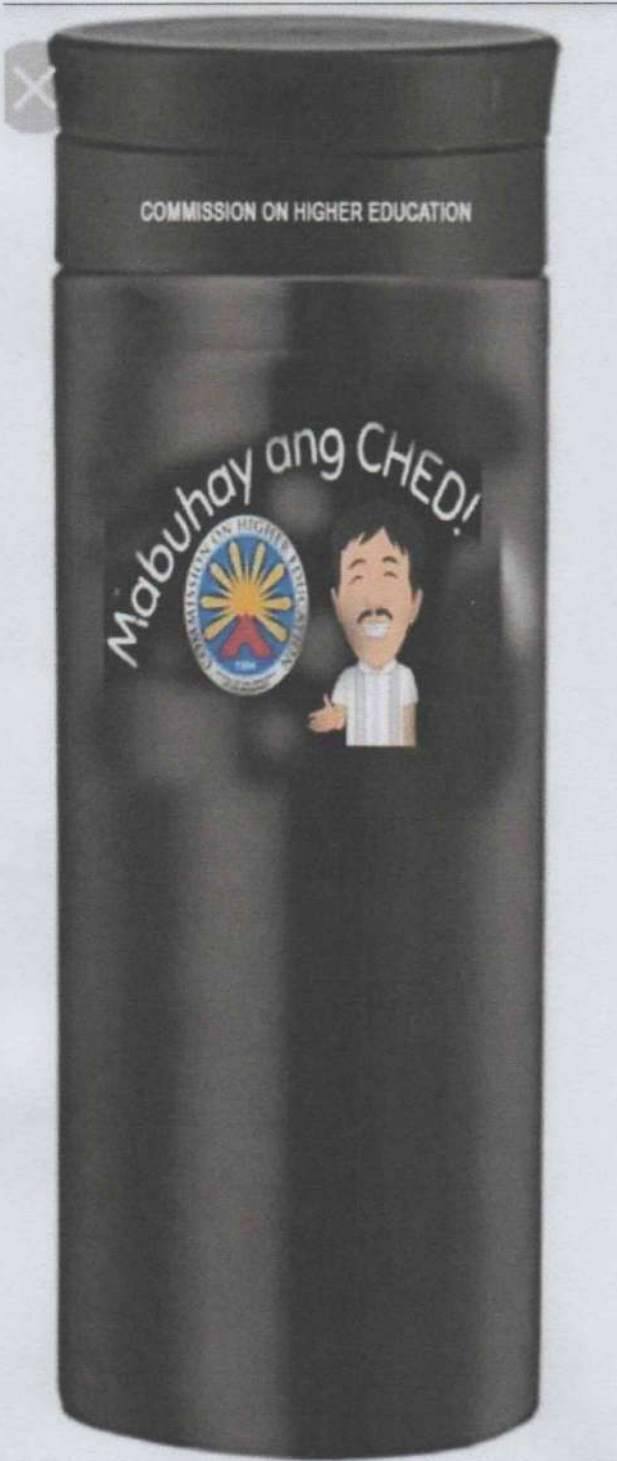

AFFIDAVIT
