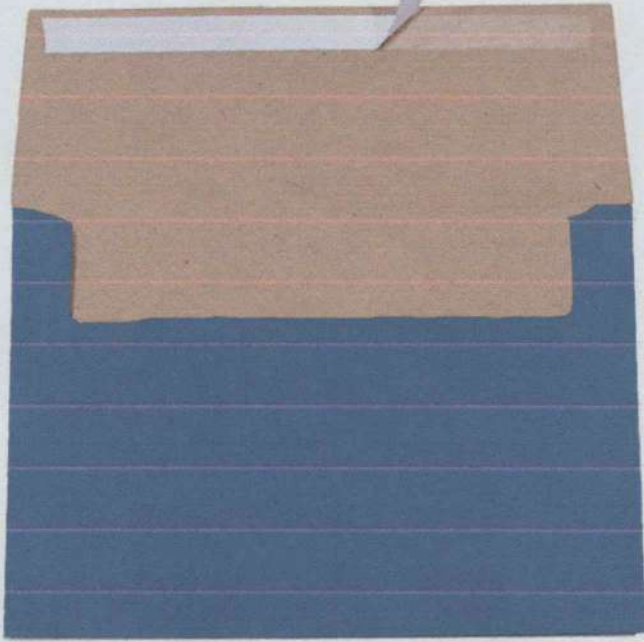

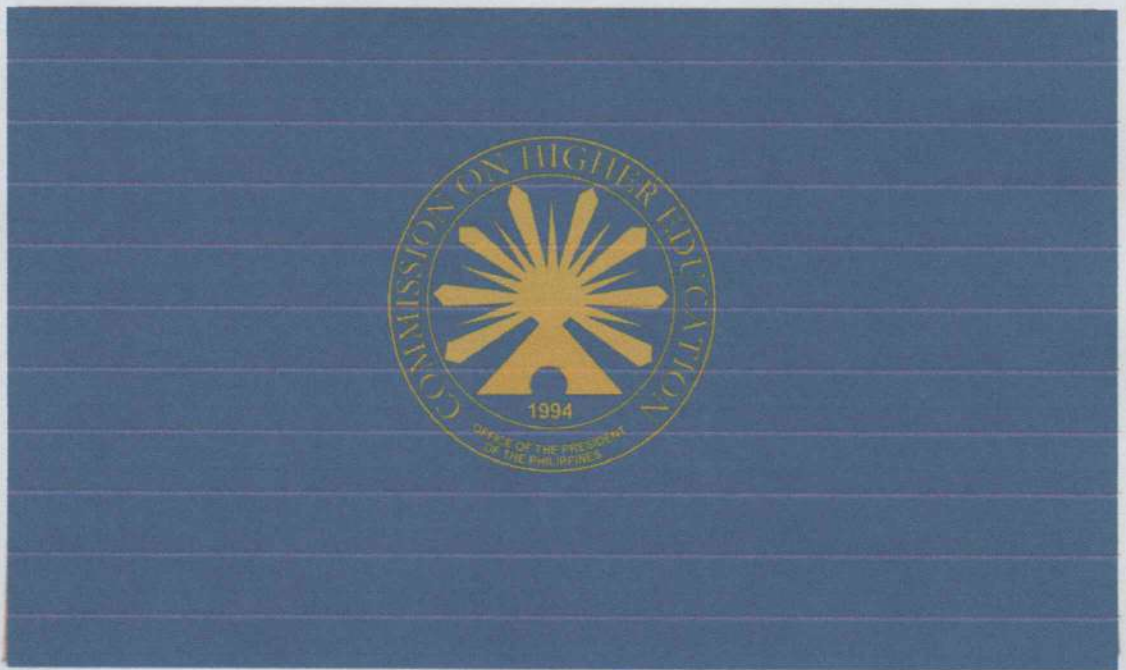

Omnibus Sworn Statement

AFFIDAVIT
