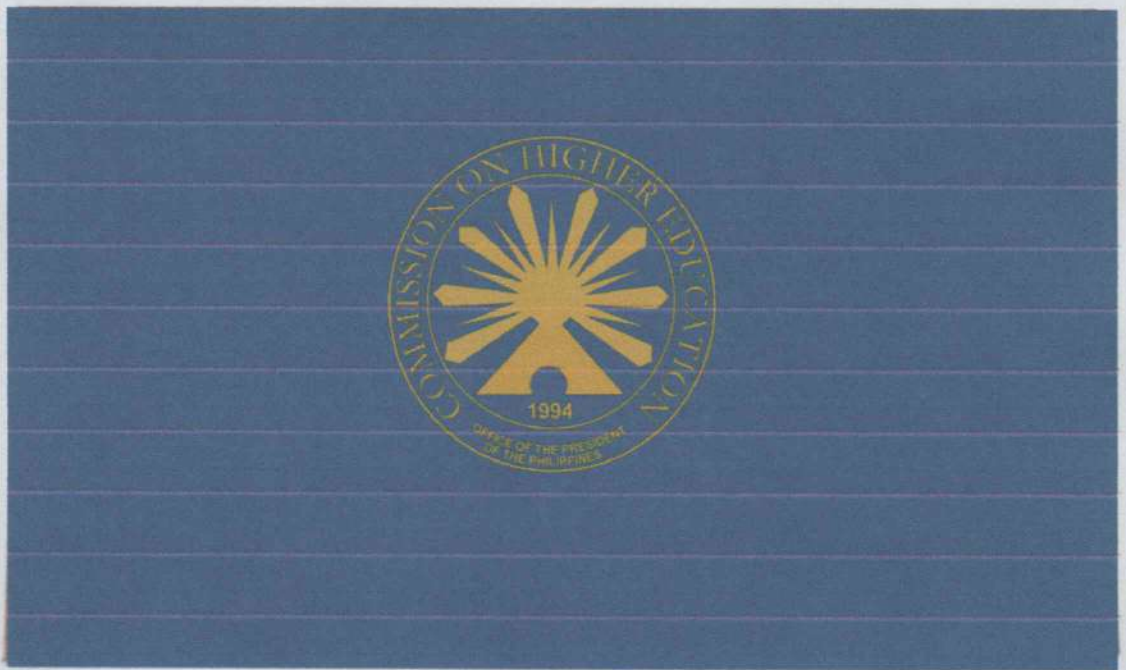

Omnibus Sworn Statement

AFFIDAVIT
