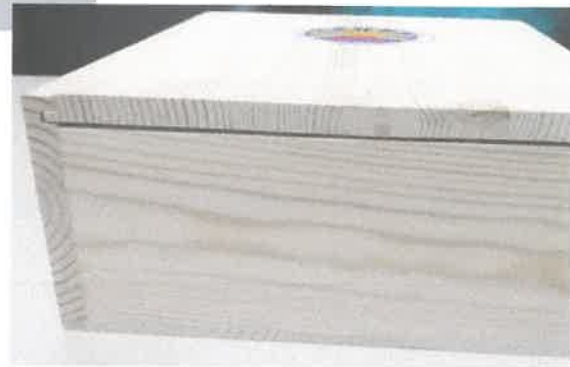

### AFFIDAVIT
